

RESOLUTION 14-120

A RESOLUTION OF THE CITY OF WESTFIELD AUTHORIZING FUNDS FOR THE FAÇADE IMPROVEMENT OF THE WESTFIELD PLAYHOUSE

WHEREAS, The City of Westfield, ("City") is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council ("Council"); and,

WHEREAS, the Council has the duty and authority to maintain and allocate funds as necessary from the duly adopted budget to maintain the fiscal integrity of the City and maximize economic development; and,

WHEREAS, certain sums have been budgeted for uses consistent with the Westfield Façade Improvement Program ("Program") as previously outlined by this Council; and,

WHEREAS, the Council has been advised of the proposed façade improvements to be made by the Westfield Playhouse; and

WHEREAS, a long term fixture of the community, the Westfield Playhouse, does not fall within the definition of those eligible under the Program but does fall within the spirit and the goals of the Program.

NOW, THEREFORE, BE IT RESOLVED by the Westfield City Common Council meeting in session as follows:

- Section 1.** The Council being duly advised now finds that the proposed improvements of the Westfield Playhouse are within the goals and objectives of the Program as intended despite the geographical location.
- Section 2.** The Council now finds that the proposed improvements of the Westfield Playhouse shall be eligible for the Façade Improvement Program incentives under the terms of the Program as well as those that the Director of Economic Development shall find appropriate.
- Section 3.** This Resolution shall be in full force and effect immediately.
